

URC is mandated to ensure the protection of the rights of all children in the Maldives. Managed the Unit and was involved in policy making at the national level towards the improvement of the situation of the Maldivian child. Much work on introducing the concept of the Right of Children was initiated at this time with awareness programmes designed to prevent a backlash by the community. Furthermore capacity building and provision of services to all outer lying atolls and island communities to children and families were achieved. National programmes such as National Registration Programme where mechanisms for birth registration of all children of the nation were established and currently remain in place, with funding secured from international donors and mechanisms set up at all levels of governance.

Treatment and rehabilitation programmes were begun at this stage where programmes targeted for young people to reduce high risk behaviour, reduce offending behaviour, and improve their protective skills such as self esteem and other life skills were conducted to groups in Male as well as in Rehabilitation Centre for Children in Maafushi.




